contract for the benefit of _____ a tiger.

Big Cat Rescue agrees to accept _____ a tiger from Donor(s) and
provide permanent lifetime care for the cat(s) for the rest of the cat's (cats') life.
In exchange for such value and services Donor(s) agree:

1. We the Donor(s) and our immediate households will never participate in the exotic pet trade, meaning that we will not buy, sell, trade, breed, harbor nor participate in secondary causes of this abuse by paying to touch, or have our photos made with exotic cats, or working with, or on behalf of non **accredited facilities that house exotic cats. **Accreditation of the American Zoological Association or the Global Federation of Animal Sanctuaries.
2. If a situation arrives where we the Donor(s) feel compelled to rescue an exotic cat we will not do so and will contact Big Cat Rescue or an **accredited sanctuary that does not breed, buy, sell, trade nor allow contact with its exotic cats, to rescue the cat in our stead.

Should Donor(s) or their immediate household break or violate this contract they hereby agree to pay to Big Cat Rescue the sum of \$7,500.00 per year for the estimated lifetime of said cat, as consideration for the services provided in the acceptance of the forenamed cats. This sum is based upon the expected lifetime cost that Big Cat Rescue is assuming by taking possession of Donor(s) cats and is non negotiable.

This contract shall be fully enforceable and shall be litigated, if necessary, in Florida. Proof of violation will be the possession by Donor(s) of any exotic animal or verifiable photographic imagery of Donor(s) posing with an exotic cat in an unaltered photo taken after the date of this contract or by Donor(s) name appearing on the board of, or working for the benefit of any non **accredited animal facility. Notice of such violation will be made to the address for the Donor(s) listed below and shall be considered good and sufficient notice.

This contract is not binding until signed by both parties before witnesses and a notary public.
